In all matters and things aforementioned, as well as in all other things necessary or incidental to the furtherance or conduct of the account of the undersigned, the aforesaid agent and attorney in fact is authorized to act for the undersigned and in the undersigned's behalf in the same matter and with the same force and effect as the undersigned might or could do. Please note that the Full POA option cannot be elected if it is for an IRA account. However, if the IRA account holder is incapacitated, then a previously existing Full POA is acceptable.

Limited to Purchase and Sale of Securities and Commodities/Discretionary Trading Authorization/IRA Trading

In all such purchases, sales or trades you are authorized to follow the instructions of _____ in every respect concerning the undersigned's account with you; and he/she is authorized to act for the undersigned and in the undersigned's behalf in the same manner and with the same force and effect as the undersigned might or could do with respect to such purchases, sales or trades as well as with respect to all other things necessary or incidental to the furtherance or conduct of such purchases, sales or trades. For purchases, sales or trades in my IRA account, you do not need to question and may rely on the instructions and representations of the above designated individual, including but not limited to their determination regarding the tax or legal implications of the action at issue. Please note that this Limited Power of Attorney is accepted for IRA accounts for trading authorization only. An IRA Limited Power of Attorney can not authorize commodity or Financial Advisor/Registered Representative discretionary trading (except for PIM accounts).

Ladies/Gentlemen:

The undersigned hereby authorizes the above noted (whose pertinent information and signature appears below) as his agent and attorney in fact to buy, sell (including short sales) and trade in stocks, bonds and any other securities and/or commodities and/or options (including uncovered options) relating to the same on margin or otherwise in accordance with your terms and conditions for the undersigned's account and risk and in the undersigned's name, or number on your books. Buying and selling commodities or options, short sells, or margin activity is not allowed in an IRA. The undersigned hereby agrees to indemnify and hold you harmless from and to pay you promptly on demand any and all losses arising therefrom or debit balance due thereon.

The undersigned hereby ratifies and confirms any and all transactions with you theretofore or hereafter made by the aforesaid agent or for the undersigned's account.

The authorization and indemnity is in addition to (and in no way limits or restricts) any rights which you may have under any other agreement or agreements between the undersigned and your firm.

This authorization and indemnity is also a continuing one and shall remain in full force and effect until revoked by the undersigned by a written notice addressed to you and delivered to your office but such revocation shall not affect any liability in any way resulting from transactions initiated prior to such revocation. This authorization and indemnity shall inure to the benefit of your present firm and of any successor firm or firms irrespective of any change or changes at any time in the personnel thereof for any cause whatsoever, and of the assigns of your present firm or any successor firm.

This Power of Attorney shall not terminate in the event of my disability or incapacity.
